#### WHAT IS THE ANSI HI-VISIBILITY STANDARD?

The American National Standard for High-Visibility Safety Apparel and Accessories (ANSI/ISEA 107) is a standard established by the American National Standards Institute. Construction, maintenance, utility, emergency responders, airport ramp personnel and many categories of off-road workers are routinely exposed to potential injury hazards from their low visibility while on the job.

This standard provides guidelines for the selection and use of high-visibility safety apparel and other high-visibility accessories to improve worker visibility during the day, in low-light conditions, and at night.

Private companies, as well as various federal, state, and local authorities have embraced ANSI/ISEA 107-compliant garments and accessories as useful PPE (Personal Protective Equipment) for workers exposed to struckby hazards.

# TYPE O, CLASS I GARMENTS

Intended for use in environments where there are struck-by hazards from moving vehicles, equipment, and machinery <u>not</u> operating on public access rights of way or temporary traffic control zones.

# TYPE R, CLASS 2 GARMENTS

Intended for use by personnel exposed to vehicular traffic from public access rights of way or roadway temporary traffic control zones. Class 2 garments require the use of greater amounts of high-visibility materials which help distinguish between a human and an inanimate object.

# TYPE R, CLASS 3 GARMENTS

Intended for use by personnel exposed to vehicular traffic from public access rights of way or roadway temporary traffic control zones. Class 3 garments mandate an even higher standard of visibility for workers in moving, complex backgrounds.

- Roadway construction personnel and flaggers
- Utility workers
- Survey crews

#### SUPPLEMENTAL, CLASS E GARMENTS

Pants, bib overalls, shorts and gaiters meeting minimum area requirements for background material and retroreflective trim. Class E apparel, however, cannot be worn alone to provide adequate visibility of workers. When Class E items are worn with Performance Class 2 or 3 apparel, the overall classification of the ensemble is Performance Class 3.

#### TYPE P. CLASS 2 & CLASS 3 GARMENTS

Intended for emergency responders and law enforcement personnel in environments with struck-by hazards from traffic operating on public access rights of way or temporary traffic control zones.

## **TYPE O, CLASS 1 GARMENTS**

"Off road" means just that, your team is off the roadway, but that doesn't mean hi-vis isn't needed. Being efficient in your line of work may mean moving fast - and when forklifts, packages, and people are moving fast accidents can happen. ## **TYPE R, CLASS 3 GARMENTS**

If your team is exposed to vehicular traffic from public access rights of way or roadway temporary control zones then they need to be in Type R, Class 3 garments. According to the NHTSA (National Highway Traffic Safety Administration) distracted driving is one of the leading causes of roadway accidents. Now more than ever drivers are paying less attention to what's in front of them and that makes wearing the correct high-visibility garment even more important. With additional reflective striping on the sleeves and body, Red Kap offers a wide range of garments to meet your Class 3 needs.



## SUPPLEMENTAL, **CLASS E GARMENTS**

Class E garments worn alone do not provide adequate visibility of workers. Think of Class E as garment types that must be worn with an "Extra" garment that is either Performance Class 2 or 3 apparel. Red Kap offers a Utility Pocket Pant that complies with Supplemental, Class E requirements of ANSI/ISEA 107-2015 and also pairs great with any of our Performance Class 2 or -Class 3 shirts.
